

MAPS GROUP CHOSEN BY EUROCOMMERCIAL FOR MONITORING CONSUMPTION IN ALL OF ITS ITALIAN SHOPPING CENTERS

Maps Group, in partnership with its subsidiary Energenius S.r.l., has been selected for the implementation of a monitoring system across all Italian shopping centers owned by Eurocommercial, a significant real estate investment company listed on various Euronext markets including Euronext Milan, and one of the leading specialists in European shopping centers.

The project involves expanding the existing monitoring system, previously installed by Energenius, to enable **real-time monitoring** of **electricity consumption** in all common areas and commercial activities within the centers. The system will also track **gas**, **water**, **air conditioning**, **lighting** consumption, and **waste production** in common areas, while keeping track of energy production and usage generated by **photovoltaic systems** in certain centers, along with calculating the produced **CO2 emissions**.

Through the **control dashboard**, Eurocommercial's central management will be able to monitor specific Key Performance Indicators (KPIs) generated by the system in real time, facilitating **comparisons** between the consumption of **centers of different sizes** and analyzing machine operations (such as air conditioners, air barriers, etc.) to **optimize maintenance activities**.

With the assistance of this monitoring platform, Eurocommercial aims to achieve **sustainability certifications** such as the BREEAM protocol for its buildings.
